## **Re: Planning Application 0/43059**

Dear Chair,

I am writing further to my letter of September 2016 (a copy of which is attached for your reference<sup>1</sup>) to further confirm my objections to this application.

As noted in the Report for this application, to be considered at the meeting of 9<sup>th</sup> August 2017, this development is "outside the urban settlement boundary and contrary to Policies HOU/1 and HOU/2 of the LDP". Further, it is "contrary to LDP Policy CTH/2" and has been advertised as "a departure from the LDP" (103). The considerable amount of local objections to this application demonstrate the frustration of many residents with regards to such a departure.


Further to this, I understand there is some conflict with regards to the years of land supply available, and would request full clarification from the Council on this matter, to include the criteria used to determine the land available, before further developments outside of the LDP are considered.

Also noted is the fact that this development will incur the "the loss of 4.57Ha of grade 3a...agricultural land" (106).

Whilst CCBC Highways have not raised objections with regards to accessibility and sustainable location, these are matters which have been raised considerably in the local objections, and I would request that these are fully considered.

The level of local objection is considerable, and I remain firmly in objection to this application, and I request that this letter is placed before the Planning Committee today for their consideration on this matter.
