Dear Cabinet Secretary, Ken,

I am writing with regards to concerns that have been raised with me by numerous constituents about the A470 in Dolwyddelan.

The road through the village currently has a speed limit of 30mph. However, I am aware that there is good reason to believe that in addition to this not being adhered to, it actually needs reducing to 20mph. Not only does the road pass through a residential area, and have cars parked on the side, the carriageway is actually very narrow in the middle of the village. Such is the danger of that particular section of the A470 that signs have been erected warning that there are 'Oncoming vehicles in middle of road'.

Given the above, I would be very grateful if you could ensure that the 30mph speed limit is being enforced, and conduct a full investigation into whether a 20mph speed limit can be introduced. Whilst I would like this to be an enforceable limit, I do not doubt that signs like those on the A470 in Llanrwst would have a positive impact on reducing the speed of vehicles going through the village, and improving both pedestrian and road safety.
